WHEREAS, on January 21, 2025, deteriorating road conditions and the winter weather necessitated closing at 3 p.m. on Tuesday, January 21, 2025; and

WHEREAS, all general office operations of the Oconee County Government and workstations for non-emergency personnel and the Oconee County Schools will remain closed tomorrow, January 22, 2025; and

WHEREAS, the emergency substantially endangers or infringes upon the normal functioning of the judicial system, the ability of persons to avail themselves of the judicial system, or the ability of litigants or others to have access to the courts or meet scheduled or time deadlines imposed by the court order or rule, statute of administrative rule or regulation;


IT IS ORDERED that, pursuant to O.C.G.A. § 38-3-61, the Oconee County Courthouse shall be closed on Tuesday, January 21, 2025 at 3 p.m., remain closed on Wednesday, January 22, 2025 and reopen as usual on Thursday, January 23, 2025. Superior, Magistrate, Probate, and Juvenile Court shall be closed from January 21, 2025 at 3 p.m. until January 23, 2025 at 8:00 a.m. Filings may still be made remotely with the Clerks of the Courts located at the Oconee County Courthouse through the following websites:

- All after hours procedures involving CHINS, Delinquency and DFACS matters shall remain in full force and effect.
