Pursuant to O.C.G.A. § 38-3-61, et seq., and Rule 45 of the Uniform Rules for the Superior Courts, the undersigned Chief Judge of the Superior Court for the Dublin Judicial Circuit of Georgia does hereby declare the existence of a Judicial Emergency in Johnson County, Georgia. The nature of the emergency is inclement weather with the expected accumulation of snow and ice on the roadways, which is expected to affect this judicial circuit from approximately 12:00 p.m. on Tuesday, January 21, 2025, through Wednesday, January 22, 2025. The undersigned makes this declaration at the request of the Johnson County Emergency Management Director.

Accordingly, it is the order of the Court that the Johnson County Courthouse be closed for business on Tuesday, January 21, 2025, at 12:00 p.m. through Wednesday, January 22, 2025, and will reopen for business on Thursday, January 23, 2025, at regular time.

This order shall immediately be posted in the Johnson County Courthouse, interior and exterior.

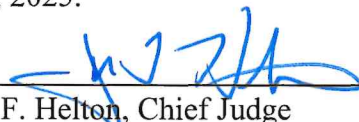

This order shall immediately be posted in the Treutlen County Courthouse, interior and exterior.

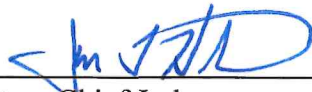
